The issue: do the benefits outweigh the purpose of conserving the natural beauty and wildlife and enabling quiet enjoyment of the environment?

The key considerations for the BMC should be:

- Would the scheme have a significant impact on the enjoyment of the area by hill walkers?
- Would it affect any rock climbing crags in the areas?
- Would it have significant visual impact?
- If the scheme were to go ahead would it be seen as a major concern by local and visiting climbers and walkers?
