## Wasdale and the pressure on Scafell Pike

Sarah Metcalfe (National Trust ) has been in contact re the pressure on Wasdale due to the popularity of climbing the highest peak in England. Additional pressure during the summer months was created by the Three Peaks Challenge.

Parking in the lay-by at the entrance to the NT car park has been blocked and folk are encouraged to use the pay and display car park. A plan is in place to make this 'pay on leaving'. 24 hr access is needed.

The Area shares the concerns but feels further consultation should be made as the parking issue is exacerbated by this type of measure. A coordinated response from the BMC MRT LDNPA and NT was felt to be the best outcome.
