

Minutes of BMC Lakes Area Meeting
held on Wednesday 27 January 2016
at Hawkshead Brewery, Staveley

Welcome and apologies

Mike Parsons welcomed everybody. Apologies were received from: Matt Le Voi, James Brumby, Kelvyn James, Ron Kenyon and Steve Scott.

1. Minutes of previous meeting, matters arising, and action points

Action points from November meeting. Further to our discussion regarding the scattering of ashes and leaving memorials, see BMC website for an article written by Hanna Lindon in response to the rising problem. Mike parsons asked if was OK to be pro-active, if people found such inappropriate memorials, could they remove them. Consensus of opinion was that as the National Trust had been doing just that for many years the answer was yes.

3. National Council Report

Ted Rogers gave his report from National Council. The draft minutes of this meeting are available in full on the BMC website. Ted highlighted the following: Martin Doyle has been replaced by Jackie Bryson as head of Plas y Brenin, who is settling in well. From area reports: it must be noted that only people with BMC insurance can climb in the Cheddar area. Peak District organised a very successfully walking day. The Olympics will be upon us soon and climbing will bid again to be an Olympic Sport. The budget forecast for 2016 is a surplus of £8k. It is expected for membership fees to remain the same. Dave Turnbull (CEO) gave a report to the meeting, the main theme of which was 'a time for change.' We are likely to see areas and committees changing with amalgamations of a few.

4. Bolt Fund

Dan Robinson gave a report on the current bolting situation. Access has been agreed for rebolting of Humphrey Head and also a crag clean-up (date to be announced). Bolting work continues at Hodge Close, Cathedral Quarry, Tilberthwaite and Thrand Quarry. Dan Middleton (BMC) offered assistance in supplying resin.

Rick Graham then gave a brief talk on the structure of the Cumbria Bolt Fund. The main concern is that the constitution is in need of updating. Rick has made some comprehensive notes, which will be circulated. He would appreciate feedback.
