Action

- 1 Welcome & Introductions. James welcomed everyone to the meeting.
- 2 Apologies for Absence. Apologies were received from Julie Dundas, Mick Johnson & Bev Jowett.
- 3 Minutes of the last meeting. These were agreed to be a correct record.
- 4 Matters Arising not covered elsewhere
- **4.1 2016 Festival.** No progress with this & now not feasible for 2016. To revisit. ? have a presence at local walking festivals.
- 5 Co-ordinators' Reports
- **5.1 Gritstone: Access & Conservation.** Mick Johnson had sent a report as follows:-

Dovestones. Ongoing. Notice at base of crag – no climbing & trespassers will be prosecuted. Landowner had put up the sign during the Tour de France to discourage people from climbing on the rocks when there were vast numbers of visitors. He has no problem with people using the rocks for climbing & would arrange for the sign to be removed. A59 in the area closed at the time so not possible to check at the time but to be followed up when road is open.

(Post meeting note – Nicky Bunting, North Yorkshire County Council Rights of Way Officer subsequently walked around Dovestones & found one sign which she removed.)

Brimham Rocks. Previous report of University Group at crag being asked re risk assessment. The National Trust has an online risk assessment form & similar also available from North Yorkshire County Council. Work re this ongoing.

Crookrise Crag. Dave Turnbull reported that discussions with the Yorkshire Dales National Park

Authority (YDNPA) about the acquisition of Crookrise are ongoing; the Park's valuation of the site is higher than that of the District Valuer.

5.2 Limestone: Access & conservation. Nigel Baker reported that Limestone Access was generally quiet at present.

Threshfield Quarry. Dave Musgrove reported positive news after 3 years of discussions. Meeting with Tarmac's new Estates Manager & Area Operations Manager both of whom are positive re the possibility of climbing in the Quarry. More work to do but possibility of starting development of the Central Corridor area later this year.

- **Youth.** Dave Turnbull reported that James McHaffie had recently started working for the BMC as Youth & Partnerships Officer to help improve the BMC's services to young people.
- 5.4 Climbing Walls. There is no Area Climbing Wall representative due to lack of interest. JR had asked about Area climbing Wall reps at the December Meeting of the National Council. Noted that some Areas have Climbing Wall reps & the BMC's position re wall reps hadn't changed. Reference to Area Meeting Guidance document which states 'BMC Areas may choose to appoint a Climbing Wall Rep to liaise with climbing walls and wall users and to refer any relevant issues to the Area. Amongst other things the Walls Rep can take responsibility for ensuring the display of BMC literature at climbing walls.' For further consideration by Area.
- **5.5 Clubs.** Paul Exley's report from the Clubs Committee Meeting of 28 January had been previously circulated.

Noted that the Huts Booking System referred to was still in the very early stages of being investigated re feasibility. Even if it was felt to be feasible there was a long way to go before a system could be available.

Hillwalking. Paul Redding's Hill Walking Report had been previously circulated. He said that there was a Hill Walking Working Group Meeting the following week & asked that people contact him re any issues &/or re info.

The **BMC's Mend Our Mountains campaign** was noted – to be launched. Of particular interest here are the proposed repairs to the Swine Tail path on Ingleborough which has been put forward by the YDNPA for funding. This gets a lot of use & the proposed crowdfunding could be very helpful in helping to fund the repairs. Dave Turnbull said that the BMC was being more pro-active in the Mend our Mountains campaign & that the BMC's Access & Conservation Trust (ACT) was heavily involved.

Honorary Membership – Angela Soper. Noted that Angela Soper (along with Gwen Moffat) had been offered BMC Honorary Membership. Angela reviewed her involvement with the BMC from the early days of being a climbing wall rep through to being a BMC VP when the big issue was relocation of the BMC Office due to lack of space.

The BMC, since its inception in 1944, had never had a female honorary member. The Meeting expressed its congratulations to Angela on this great honour.

Dave Turnbull said that the BMC was considering what more it could do for its female members & that the honouring of Gwen and Angela was one of the first results of the new BMC Women's Think Tank, which had its initial meeting in Sheffield on 2 December.

Also that the BMC was going to try & have a crèche facility at the AGM & also to offer to cover childcare expenses to help women with childcare responsibilities to try to get to meetings.
