3. Minutes of previous Meeting

6. Co-ordinators Reports

Access North

- Howlerhirst ban lifted unless nesting peregrine nesting reported.
- Kyloe In No reported access issues. Social media used to raise parking awareness.
- SB reported a conversation with a landowner about High Crag approaches. Still to be acted upon further.

Access South

- Ornithological developments. Climbers now safe from Pterodactyls in various locations.
- Clemmitts access issues. Ban articulated by head keeper. Not open access land. Close to national cycle hub and the MTB trails development may be antagonising the situation.
 - Have spoken to head keeper who is permitting climbing at Danby. Note: there are typically three levels of engagement: land owner / agency / usage (gamekeeper).

Youth

Clubs

- Call for members to fill this role as it is vacant.
- Most of the clubs' committee time has been working on ORG matters
- New 'club' in North of the area 'Newcastle upon Climb' Facebook group but not affiliated to BMC. Concerns have been raised over conduct of large group (~20) at Shafto, and poor top rope technique at Corbys, which suggests the group are relatively inexperienced and could benefit from some guidance.
 - Possibly BMC to reach out to them. re liabilities, best practice, étiquette etc. MA TO ACTION

7. Organisational Review (ORG) and the recent work of the Implementation Group (IG) See report appended

MA (augmented by DT) reported on developments:

- Majority of the Board (at least 7) will have to have been BMC members for at least 12 months
- Membership will vote on majority of Board Members at AGM
- Chair of the Board need not be 'independent' they could come from 'within' the BMC. There had previously been an incorrect assumption that SE required us to appoint an Independent Chair.
- Nominated Directors BMC can seek appointments from other stakeholders / partner organisations.
- Various compromises reached including establishing a MOU between Board and NC. Majority of NC members voted in favour National Council Amended Articles. MA and JP abstained owing to response of area at the last meeting.

A second set of articles has been submitted by a different group. There is a choice at the AGM.

Members are encouraged to vote since 75% is required in favour of one set of articles for them to be adopted.

John Roberts has submitted a motion so that if no articles are adopted, the BMC will continue work on a proposal in the spirit of the ORG before returning to members.

Feedback given by members about the complication of the voting form.

MA ran through the AGM agenda.

Fliers distributed canvassing Lynn Robinson for President. Les Ainsworth canvassed in person for President (15 minute presentation followed by questions).
