- 1 Welcome & Introductions. David welcomed everyone to the meeting.
- **Apologies for Absence.** Apologies were received from Anne Chevalier, Martin Christmas, Bev Connor, Glyn Edwards, Jon Garside, Dennis Gray, John Hunt, Gareth Morgan, Laurie Morse, Angela Soper & Dick Winslow.
- **3 Minutes of the last meeting.** These were agreed as a correct record of the Meeting.
- 4 Matters Arising. There were no matters arising.
- 5 Co-ordinators' Reports
- 5.1 Gritstone: access & conservation.

Access to Cat Crags, Brandrith, Upper Huller Stones & Sypeland. Rob Dyer, BMC Access Officer was in process of responding to the original letter re this which was trying to impose some access restrictions. It was noted that such restrictions were not acceptable on Open Access Land.

Whinswood. An access query re this had been resolved by contacting Mel Smith at Bradford Council and the crag will be included in the forthcoming Gritstone Guide.

Derby Delph. A query had been raised re this being a SSSI site which could affect work on it re the new Gritstone Guide. However Rob Dyer had confirmed that it is not now shown as such on RAD.

Eavestones. 'Private. Keep Out' signs noted. Rob Dyer informed. Not thought to be Open Access Land. ? temporary restriction re bird rearing. Ongoing.

Caley Clean Up. Excellent work by Forest Ranger and his team of two in lopping & chopping down trees near to boulders in the vicinity of Sugar Loaf boulder. More work planned.

BMC to fund cost of strimmer hire to tackle the Himalayan Balsam at an appropriate time in 2011. Volunteers still needed to help pull it up.

Roundhill Access. Previously reported problem re car parking not an issue.

Great Wolfrey. Two potential access points have been suggested. Nothing heard yet from National Park so to follow up.

Crow's Nest Wood – suggestion of possible hazard - ? was once an asbestos dump.

Holmfirth Edge – ACEG report re site visit re suitability for management by the BMC. Concern that the Gritstone Rep was not involved in the visit.

5.2 Limestone Access & Conservation.

Kilnsey – concerns raised re climbers' toileting habits at the crag. Suggestion re health hazard as near stream & fact that it's near the road so activities are clearly visible. Education need. General concern that Kilnsey attracts climbers from all over and many seem totally unaware of issues such as parking etc. The BMC signs here need relocating – people don't see them in their current locations.

Beggar's Stile – confusion re access. Open Access line appears to be along top of crag. Landowner interprets this as no right of access and climbers that there is right of access which is thought to be correct. Rob Dyer aware. Need to update RAD in short term whatever the long term outcome is.
