# **Minutes - Cofnodion**

Attendance: - A total of 48 were recorded on Zoom's participants list. However, this is not necessarily an accurate record of attendance and includes approx. 10 non-voting BMC members, resident outside the N Wales area.

## 1. Welcome and apologies for absence

The chair, Tim Jepson, opened the meeting. Apologies were received from: Pete Johnson, Lun Roberts, Ian Martin, Gwyn Jones.

Before continuing with the AGM, the Chair acknowledged the difficult circumstances that so many N Wales members found them themslves in due to the Covid 13 pandemic, especially those generating an income in outdoor sectors.

#### 2. Quorum
