- 1 Welcome & Introductions. James welcomed everyone to the meeting.
- **2** Apologies for Absence. Apologies were received from Anne Chevalier, Glyn Edwards, Mick Johnson & Heather Thomas Smith

Harpur Hill. Noted that parking problems are ongoing..

- 5.1 Gritstone: Access & Conservation. Report from Mick Johnson.

Woodhouse Scar, Heptonstall & Shipley Glen – Working party established with Calderdale Council to improve access at both Heptonstall Quarry and Woodhouse Scar. At Heptonstall new stakes are going to be placed at the top of the quarry and a lot of tree clearing and pruning will take place. At Woodhouse there is going to be a lot of tree pruning of the trees below the crag.

Shipley Glen - Tree pruning planned in conjunction with Bradford Council and the Parks Department.

5.2 Limestone Access & Conservation.

Liaison Meeting with Yorkshire Dales National Park (YDNP) – No concerns raised. Bird breeding gone well.

Foredale Quarry. Discussions with the farmer now stalled. He still doesn't want climbing at either Foredale or Moughton Nab & claims he has a tenancy agreement for Foredale but refuses to say who with, so trying to establish land owner. Land surrounding Foredale is Access land, except for Quarry base and field on old approach; so trespass potential.

Moughton Nab. All of Moughton Nab and its approach is Access land but best approach is to park near Dry Rigg Quarry and walk up from there.

Giggleswick Quarry: Quarry is at the end of its life & not worked for 2 years. Original suggestion for climbing not progressed due to owner's concerns re health & safety, liability, etc. This summer c12

routes were bolted by unnamed person(s). Climbing took place for several months, before the owners found out; complaining to the BMC and the police. Bolts removed. Meeting planned with Quarry owners & YDNP. Noted that YDNP are supportive of use for climbing.

Kilnsey Crag. No progress had been made since September's meeting but it was felt that the issues of parking, repair of the path (that joins the left & right crags) and (composting) toilets should be sensitively investigated further.
