## Appendix A - BMC SW Area Discussion Paper of Future Funding For Access Issues (July 2024)

At our last area meeting we saw a video of two US Access activists describing how, in the US, access to climbing and hillwalking is funded. In summary, "Purchasing and owning climbing sites is very popular amongst climbers in the US. Not only does it secure long-term access it also helps build a sense of community, encourages membership, prompts volunteer initiatives and generates financial giving."

For those present at the meeting, this presentation raised questions about how access is funded via the BMC, and so we agreed to discuss this further at the July Area Meeting.

How does the BMC make funds available at the moment for access work?

- Requests for small expenditures such as refreshments at a crag clear-up day are met out of the BMC's current allocation to AC&S expenditures.
- Requests for moderate expenditures e.g. £500 for stakes, have been met via a simple application mechanism, though the decision-making may not be rapid.
- For much larger sums, e.g. ClimbBristol, applications would need to be made to the BMC's Access and Conservation Trust.

It is likely in the near future that both moderate and large sums will be needed in different parts of the South-West to fund access projects. To take things forward we need to make sure our representatives to Members Council, Trevor Smith and Philip Wilson, are fully informed of our opinions on the following issues:

- Q. Are the BMC's current mechanisms suitable for the needs we foresee in the next couple of years?
- Q. If our Access Reps need to ask for any crowd-funding to supplement anything the BMC can offer, how are we to ensure that crowd-funded money is managed and used ethically, transparently and effectively?
- Q. If the BMC were to offer funding for a project on a part-basis, should that be conditional on a certain proportion being raised by any crowd-funding (e.g. BMC/Crowd 50/50? 25/75? 10/90?)
- Q. Should the BMC's current policy on crag purchase [i.e. as an action of last resort] remain as it is, or should the BMC be more proactive in securing climbing areas? (When you consider this question, please also consider the on-costs of owning and caring for a publicly accessible site as annually they could be quite considerable.)

Q. Are there any other questions that we should be asking as part of this discussion?
